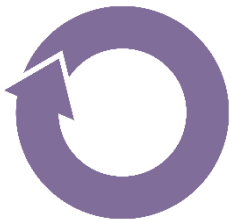
Register Your Business on the City of Seattle Online Business Directory (OBD)

Consultant Services

Direct Select: is used when the total value of the work is less than \$53,000 spend within one year. No professional services.

Consultant Roster: may be used when the total value of work is less than \$314,000. Businesses must be registered and approved for the Roster on the OBD.
(WMBE Inclusion Plan, optional)

Full Solicitation: Request For Proposals (RFPs) and Request For Qualifications (RFQs) can exceed \$314,000.
(WMBE Inclusion Plan is required)

Purchasing

Per City of Seattle policy, SPU primarily uses Blanket Contracts established by the City's Purchasing & Contracting Services Division (CPCS) for purchasing needs.

Beyond Blanket contracts, the City can undertake direct purchases (<\$8k) or informal solicitation (<\$53k).

No professional services are allowed under purchasing contracts.

Public Works

Per City of Seattle policy, the City of Seattle's Purchasing and Contracting Services (CPCS) Division administers Public Works (Construction) contracts for SPU.
