This is the only communication I have in my archives related to Scott from July 2014. The language I use – that I “suspect SDOT’s got some contracts with Alta” – makes me question whether I sent this email after Gary and I sat down with Scott or not.

As for what Gary and I discussed with Scott in that session, I am practically certain that his past work at Alta came up, and I can’t imagine that we didn’t make clear that he would need a waiver to participate during the first year and that after that year expired a simple disclosure would do.
