	Topic Area	Question	Answer
1	Eligibility	Since the funding is from the City of Seattle, is it available to communities outside of City limits?	Yes, Home Delivered Meals must be served in all regions of King County.
2	Website	The links on the timeline table is unresponsive and I'm unable to copy and paste into another browser. Please help.	The timeline chart is an image so the links do not work. The same information is repeated further down the page with active links.
3	Application	The RFQ references Attachment 9, Dietary Reference Intake. Where do I find attachment 9?	The guidelines and application have been updated. The Dietary Reference Intake can be found in Attachment 8.
4	Model	The RFQ states examples of Medically Tailored Meals (MTM) for specific medical conditions. Are there other MTMs that the RFQ would like to see besides the examples mentioned?	The examples stated in the RFQ are examples only. There are no specified MTM's that we would like to see.
5	Model	The Culturally Nourishing Foods for Older Adults RFP states that at least \$100,000 of the total RFP funds will be allocated to delivered meals, but you also have a Home Delivered Meal RFQ funding opportunity. Are there differences in services being offered in Culturally Nourishing Foods RFP compared to the other funding opportunities?	Yes, Culturally Nourishing Foods RFP opportunity is specific for Seattle residents and includes activities and services to populations that would not otherwise be allowable under other funding opportunities. This includes groceries, to-go meals, or delivered meals to populations that don't meet Home Delivered Meal RFQ participant eligibility guidelines. (See Culturally Nourishing Foods for Older Adults question 18).
6	Other	Who makes up the rating committee?	The rating committee has people with knowledge and experience working with older adults, priority and/or focus populations, food and/or nutrition experience, members of our advisory council and a counter part from another Area Agency on Aging.
7	Other	When will the website be updated with questions and answers?	Official responses to questions will be posted on the website within 5 business days.
8	Eligibility	Is the funding open to organizations only within City of Seattle limits? We serve a ton of folks with Seattle addresses but located in unincorporated King County.	Funding is open to organizations outside of the City of Seattle limits. (See question 1).
9	Eligibility	Are organizations that are currently providing meals to residents eligible to apply? Or is this RFQ only	This is an open, competitive process. All agencies, including currently contracted providers, need to apply. Agencies need to serve meals in all
